A research project involving humans subjects, animals and biotechnology, may require a certificate of ethic approval. Please apply your documents to Ethic Review Board (ERB) of Rangsit University (building 1, room 1-503). You can download and study some more information at URL: <http://ethics.rsu.ac.th>. Researchers can received the first annuity only after the approval of ethic certification.

The proposal submitted after due date (30th June 2024) may be suspended for the next round of grant approval.

Criteria for applicants eligible for Research Funds

1. Principal Investigator

- 1.1) Principal investigator must be a lecturer or personnel who passed the probation period and has been officially appointed from the Personnel Office as a full time lecturer or staff.
- 1.2) Principal investigator must not in the status of leaving for studying or leave without pay both officially and unofficially informed.
- 1.3) Principal investigator must take main part for research work with the responsibilities in research design, data analysis, and research result conclusion.

2. Dean must approve the principal investigator, co-researcher, and research assistant that the research will not affect their current workloads.

3. The principal investigator must complete the previous research work funded by the Research Institute and already published their previous finding. In this regard, a copy of a published research article must be attached to a new research proposal to confirm the completion of the last work.

4. A proposal related to humans subjects or animals experimental must be processed for a certificate issued by Human Ethics approval to the Ethics Committee or the Animal Ethics Committee. Please declare the current condition such as certificate certified, under processing, or others. Without the ethics certificate, the funding will be refused to disburse.

5. Research Duration

The research timeline should be conducted within 1 year (12 months) and the maximum budget for a proposal must not exceed 150,000 Baht per research subject.
